#### American Legion Baseball – Sgt At Arms Scott Perry -

#### **Oratorical Contest - Cdr Whiteley - Oratorical Contest Assigned Topics -**

Amendment II – A well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.

Amendment XXIII – The District constituting the seat of Government of the United States shall appoint in such manner as the Congress may direct:

A number of electors of President and Vice President equal to the whole number of Senators and Representatives in Congress to which the District would be entitled if it were a State, but in no event more than the least populous State; they shall be in addition to those appointed by the State, but they shall be considered, for the purposes of the election of President and Vice President, to be electors appointed by a State; and they shall meet in the District and perform such duties as provided by the twelfth article of amendment.

Amendment XXV, Section 3 – Whenever the President transmits to the President pro tempore of the Senate and the Speaker of the House of Representatives his written declaration that he is unable to discharge the powers and duties of his office, and until he transmits to them a written declaration to the contrary, such powers and duties shall be discharged by the Vice President as Acting President.

Amendment V - No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a grand jury, except in cases arising in the land or naval forces, or in the militia, when in actual service in time of war or public danger; nor shall any person be subject for the same offense to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, not be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation.

**Military Suicides** - September 2023 - The goal of this month is to reach out to those affected by suicide, raise awareness and connect individuals with suicidal ideas to treatment services. DOD has rated the first quarter of

2023 with a total of 176 Suicides: Amry Component – 94, Reserve Component 41, Reserve 18, and National Guard 23.

#### **Patriotic Observance – September 2023**

**September 1, 2023 - Suicide Prevention Month**; The goal of this month is to reach out to those affected by suicide, raise awareness, and connect individuals with suicidal ideas to treatment services.

September 1, 2023 - Library Card Sign-Up Month; This month reminds parents, caregivers and students that signing up for a library card is the first step toward academic achievement and lifelong learning.

September 2, 2023 - V-J Day (Victory over Japan) - Sept. 2, 1945 is the American date of VJ Day. Also known as Victory Over Japan Day, this date marks the formal surrender of Japan in World War Two aboard the USS Missouri in Tokyo Bay.

**September 11, 2023 - National Day of Service and Remembrance** National Day of Service and Remembrance, also known as Patriot Day, commemorates the memory of the people killed in the Sept. 11 attacks in 2001.

September 15<sup>th</sup>, 2023 - Hispanic Heritage Month - Every year, America celebrates Hispanic Heritage Month from Sept. 15 to Oct. 15, honoring the contributions and sacrifices Hispanic and Latino Americans have made to the nation, it's culture, and industry.

**September 15<sup>th</sup>, 2023 - National POW/MIA Recognition** Day - The Defense POW/MIA Accounting Agency (DPAA) official site says more than 83,000 service members are missing from conflicts from World War Two to the present time. Of that number, the majority (more than 73,000) are missing from World War Two. The number of POW/MIAs from the Korean conflict number just above 7,000.

Vietnam has over 1,600 listed, with the Cold War at 126 servicemembers listed as POW/MIA. Conflicts since 1991 have six people still unaccounted for.

Of the more than 83,000 service members listed as POW/MIAs, approximately half are "presumed lost at sea" according to DPAA.mil. Roughly 75% of the entire number of POW/MIAs are thought to be in the Asia/Pacific theater of operations.

**September 17<sup>th</sup>, 2023 - Constitution Week -** Sept. 17th is the day when two important observances take place: Citizenship Day and Constitution Day. There is also Constitution Week which is observed the week of Sept. 17 – 23. The Library of Congress official site describes these observances as being created to both commemorate the signing of the Constitution on Sept. 17, 1787, and "recognize all who, by coming of age or by naturalization, have become citizens." During this time, the U.S. Citizenship and Immigration Services "encourages Americans to reflect on the rights and responsibilities of citizenship and what it means to be a U.S. citizen."

September 18<sup>th</sup>, 2023 - Air Force (USAF) Birthday – The official Air Force Birthday is recognized as Sept. 18, 1947, the date of the passage of the National Security Act of 1947. That legislation created what would later become to known as the United States Department of Defense. This established the United States Air Force as a separate branch of military service. The 75th Air Force Day will be celebrated on Monday, Sept. 18, 2023.

September 18<sup>th</sup>, 2023 - Air National Guard Birthday - The National Guard includes the Army National Guard and the Air National Guard. These two components have a mission to equip, train, and deploy when needed in

emergencies for contingencies around the world. The National Guard Birthday will be observed on Wednesday, Dec. 13, 2023. The Air National Guard will be observed on Monday, Sept. 18, 2023.

September 24<sup>th</sup>, 2023 - Gold Star Mother's Day - Gold Star Mother's Day is observed on the last Sunday in September which will be Sunday, Sept. 24, 2023. Gold Star Mother's Day is intended to recognize and honor those mothers who have lost a son or daughter in the service of the U.S. Armed Forces.

Each year there are events and meetings to publicly express love, sorrow and reverence toward Gold Star Mothers and their families. Flags are also mandated to be displayed on government buildings on this day. Army.mil says Gold Star Mother's Day is intended "to recognize and honor those who have lost a son or daughter in the service of the U.S. Armed Forces".

September 29<sup>th</sup>, 2023 - VFW Day - The third Friday in September is recognized as POW/MIA Day, a time to remember the sacrifices of prisoners of war (POW) and servicemembers who are missing in action (MIA). Until 1979, there was no formal recognition day set aside for these important men and women in uniform. POW/MIA Day will be observed on Friday, Sept. 15, 2023.

National Security – Cdr. Grant B. Whiteley – A Case for Greater U.S. Engagement in Central Asia -Since the U.S. withdrawal from Afghanistan, Central Asia's general perception of the United States has been that it's a transient and opportunistic foreign power. Polling (PDF) on Central Asian public opinion of great powers (Russia, China, and the U.S.) from 2017–19 was not favorable for the United States. On a 100-point scale, with 100 meaning "very favorable," the average opinion of the U.S. in Kazakhstan, Kyrgyzstan, and Tajikistan was in the 50s and at 76 in Turkmenistan. In all countries, public opinion on the U.S. lagged behind Russia and China. This data was, notably, collected before Russia's 2022 full-scale invasion of Ukraine. However, a decrease in support for Russia does not necessarily translate to an increase in support for the United States.

Central Asia's souring relations with Russia and growing skepticism of Chinese influence have created a window of opportunity for the U.S. to bolster its image through greater long-term investment in the region. Because the U.S. is unlikely to outspend China or even Russia, its approach needs to be deliberate and focused on areas where it can see the greatest return on investment.
